**BY ORDER OF THE COURT:**

Upon consideration of appellant's May 3, 2019 jurisdictional statement and appellee's May 21, 2019 response to the jurisdictional statement, it is ORDERED sua sponte that this appeal is dismissed without prejudice to refile once the circuit court completes all judicial labor in the underlying case. *Medeiros v.
